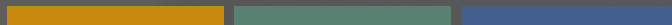

A Message from the Executive Director

In 2014, the Foundation moved forward with even greater intensity, focus and commitment to expanding opportunity for more people. Over the past two decades, our annual grant making has increased more than sevenfold from \$50 million to over \$375 million last year. We collaborated with more than 1,900 partners on initiatives across the U.S. and the world. If you could travel with me to our grantee communities, you would see schools that are providing transformative educational opportunities and preparing students for success in college and careers. You would see a riverbed that once was barren, now showing visible increases in vegetation thanks to a historic “pulse flow.” And you would see a father teaching his son to ride a bike on a new greenway trail, linking families and nature.

It’s these moments of truth that inspired our planning for the next five years. In each of our three core areas — K-12 Education, the Environment and the Home Region — we are challenging ourselves and our grantees to think big. We are scaling up our impact on not just one school, one neighborhood or one freshwater stream, but across cities and entire ecosystems. We are combining lessons learned at the frontlines with clear measurement.

Nobody thought bigger than Sam and Helen Walton. They had an unshakeable belief in the power of individuals to transform their lives. As Sam said, “There’s no limit to what plain ordinary working people can accomplish if they’re given the opportunity, the encouragement and the incentive to do their best.” Today that “no limits” philosophy is carried forward by by their descendants.

The Foundation is more committed than ever to grant making that drives not just incremental but transformative change. Here are some ways we are going about it:

In education, the heart of our mission remains the same. We believe it’s not about where you start in life but how far you can go. We envision a future where every child has access to high-quality educational choices that prepare him or her for a lifetime of opportunity. We know that empowering parents and students with options works, but now we want to do more. We have learned that while choice is vital, it is not enough. Over the next five years, the Foundation will make investments in K-12 education to increase access to real-time information about school quality for parents, be more inclusive of teachers and school leaders and ensure that our investments are reaching more of the most disadvantaged kids, especially those living in poverty and those with special needs.



A Message from the Executive Director (continued)

We believe that a healthy environment drives a strong economy. Around the world we support economic incentives for sustainable resource management, and we will continue to work toward lasting, common sense conservation. We partnered on sustainable seafood labeling for the U.K. retail industry so that consumers can make more informed decisions. In the Midwest and Southeast of the U.S., a network of 1,000 farmers have cut fertilizer use by an average of 25 percent and saved \$16 per acre without reducing their crop yield. And along the Gulf Coast, we're collaborating with an alliance of business leaders to advocate for sustainable restoration efforts in Louisiana's wetlands and coastline. In 2015, we will continue to support the work of our grantees seeking lasting conservation outcomes in ocean and river systems.

The Walton family will continue to give back to the area that it calls home, a commitment that started with Sam and Helen Walton and has spanned generations of family members. The Foundation has pledged up to \$302 million over the next five years to create and sustain long-term economic development opportunities that will measurably improve the quality of life across Northwest Arkansas and the Arkansas and Mississippi Delta region. In Northwest Arkansas, we will focus on expanding the arts and cultural amenities, strengthening coordinated regional development and preserving a sense of place. In the Delta, we will align with grantees to support Pre-K-12 education, improve public safety and engage and develop young people.

Throughout this report, you will read more about our grantees and their progress. I'm so grateful that I get to work with partners, staff and a Board of Directors who have such a passion for making a difference. Thank you to all the tireless champions working at the frontlines of change every day. There are truly no limits to what we can accomplish together.



Investing to Improve Education

Access to high-quality schools is a basic right for all Americans, regardless of their ZIP code, background or income level.

Sadly, it is a right that is being denied to far too many of our children.

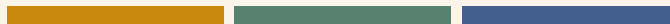


Our mission is to improve K-12 outcomes for all students, especially those of limited means, by ensuring access to high-quality educational choices that prepare them for a lifetime of opportunity.

Since an excellent education is critical for giving all kids a lifetime of opportunities, we believe that if we expand the number of quality schools to choose from, student outcomes across all schools will significantly improve.

We've seen enormous progress over the past 20 years and know that all children can succeed if given the opportunity. Across the country, we've focused our investments on providing parents and students with more public charter school options, and now many of those schools are some of the highest performing in their districts.

Throughout 2014, we made K-12 investments totaling more than \$202 million, with the goal of providing parents and students with options that work for them.



K-12 Grantee Spotlights

Families for Excellent Schools:

Great schools should be available to every child. Families for Excellent Schools is an organization that supports public school families to advocate for policies that create and sustain excellent schools in Connecticut, Boston and New York City. FES is currently running the *77,000 Reasons to Believe* campaign in Massachusetts, which calls for a bold new plan to make Massachusetts the first state to eliminate racial and socioeconomic achievement gaps and offer every child a world-class education. Across the Northeast, FES is uniting parents and cities to demand more great schools and replicate the excellent schools, both district and charter, for the benefit of their children's future.



Lee Montessori, REACH Charter School and Libertas School of Memphis:

In 2014, the Foundation provided 123 startup and expansion grants to private, district and charter schools of choice throughout the country. Lee Montessori opened in fall 2014 for preschool – 5th graders in Washington D.C., providing an environment for teachers to create differentiated instruction and individual learning paths for each child. REACH Charter School, opening in 2015, is an inclusive elementary school in Denver that creates an individualized learning plan for each student's skill level in partnership with their family. Libertas School of Memphis will teach a rich liberal arts curriculum paired with a high expectations culture and will focus on practices from other successful urban teaching environments.



K-12 Grantee Spotlights

TNTP:



TNTP works to end educational inequality by providing excellent teachers to students who need them most and by advancing policies and practices that ensure effective teaching in every classroom. In May 2014, TNTP began working with Camden City School District – New Jersey’s lowest-performing district – and supporting its ambitious plans to empower schools and dramatically improve student outcomes. TNTP helped the district streamline its central office structure to better support diverse school options and design a central office performance review process to increase accountability for central office staff. TNTP improved the way Camden staffs vacancies and recruits top talent. TNTP also launched Camden PLUS, a rigorous program to recruit, develop and coach great school leaders – each critical first steps to giving all Camden students the education they deserve.

NACSA:

Accomplishing quality schools at scale requires taking accountability seriously. The National Association of Charter School Authorizers’ *One Million Lives* campaign engages charter school authorizers, along with a broad coalition of school operators, lawmakers, funders and others to lead the way in closing failing charter schools and opening excellent ones. They accomplish this through advocacy for stronger laws that support smarter growth and accountability and providing resources to empower authorizing staff to make critical decisions. Nearly two years into the campaign, more than 200 underperforming charter schools have been closed and over 500 high-quality schools have opened.




K-12 Grantee Spotlights

Urban League of New Orleans:

Urban League of New Orleans is working to expand its Parent Information Center, which serves as a central hub to educate parents about school choice and navigate the New Orleans education landscape. Additions include an early-childhood parent guide, increased access and parent support to ESL families and continued development of the annual Schools Expo, which brings families together with over 100 schools and community-based resource providers in the city. In 2014, 98 percent of families reported that attending the expo increased their knowledge of school options and the types of schools in the city.

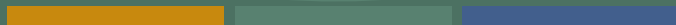

Investing to Help Environments Thrive and Communities Prosper

Conservation solutions that consider the economic needs of local communities stand the best chance of delivering lasting results. That's why we support organizations and projects that aim to simultaneously strengthen local economies and restore the environment.

In June 2014, Barry D. Gold, a longtime leader in environmental science and conservation, joined the Foundation as director of our Environment Program. With nearly three decades of experience, Gold oversees all freshwater and marine conservation grant making.

Over the last six years, the Foundation has invested in efforts to support lasting ecological restoration in the Gulf of Mexico, tackle water policy challenges in the Colorado River Basin and water quality issues in the Mississippi River Basin, and conserve ecologically rich seascapes in the Gulf of California, Indonesia and across the globe to push for sustainable fisheries management that benefits communities and families.

In 2014, we invested \$101.3 million in projects from Iowa to Indonesia that focus on common-sense approaches to protecting our rivers, oceans, land and wildlife, and the families that depend on them. From spreading innovative methods that save farmers money while restoring local watersheds to protecting turtles while enhancing local tourism, we're continuing our tradition of creating unique partnerships to tackle big conservation challenges.



Environment Grantee Spotlights

FishChoice Sustainable Seafood Calculator:

FishChoice.com provides the industry with resources that are easy to use, up-to-date and designed to fit their business needs. The organization created the Sustainable Seafood Calculator to provide seafood buyers with an easy-to-use online tool to evaluate and track the sustainability of their seafood. Following the Walton Family Foundation's tenets, FishChoice makes it easy for businesses to make practical choices, while still protecting the environment and our seafood supply for generations to come.

National Young Farmers Coalition:

National Young Farmers Coalition, working with Family Farm Alliance, organized a study of young farmers seeking more water efficient farming approaches across the Colorado River Basin. They also produced a short film, "Resilient: Soil, Water and The New Standards of The American West," highlighting the work of innovative farmers and ranchers who are adapting to a drier climate by building soil, enhancing irrigation efficiency and saving water.



Environment Grantee Spotlights

World Wildlife Fund:



The World Wildlife Fund's (WWF) rights-based management projects in the Eastern Pacific are essential to sustain the future health and productivity of the region's valuable tuna and domestic fisheries and to secure the livelihoods of those dependent upon the fishing industry. WWF is working in Ecuador on one of the most powerful tools in the efforts to sustain our critical oceans by building on the advancement of rights-based management opportunities for the Pomada shrimp fishery by developing partnerships with important industry organizations and governments. They're also coordinating activity at the country, regional and international levels.

Coalition for Coastal Resilience and Economy:

Greater New Orleans, Inc. launched the Coalition for Coastal Resilience and Economy (CCRE), a non-partisan group of Southeast Louisiana business leaders, which will act as a unified voice for sensible and effective restoration efforts in Louisiana's wetlands, rivers, delta and coastline. CCRE supports an integrated "three-legged" framework of coastal restoration, appropriate structural flood mitigation and non-structural flood mitigation. It also advocates for policies that promote, protect and drive resources to Louisiana's coast.



Environment Grantee Spotlights

Field to Market:

A new free online tool was launched in 2014 for farmers to analyze and transform their data to create a “fieldprint” of their unique operation. Developed for corn, cotton, rice, wheat, potatoes and soybean growers, the Fieldprint® Calculator estimates field level performance on land use, irrigation water use, water quality and energy use, among other sustainability indicators. This new tool will help farmers measure and improve their environmental performance.

Colorado River Pulse Flow:

The Environmental Defense Fund, The Nature Conservancy and Pronatura Noroeste, together with the U.S. and Mexican governments, crafted a landmark agreement to collaborate on conserving and sharing water. Part of this agreement was to deliver a “pulse flow” of water into the dry Colorado River bed in Mexico to benefit riverside plants, birds and other wildlife.

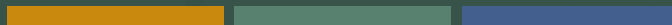
This historic flow has led to visible increases in vegetation, reversing a 13-year decline. Smaller amounts of water will continue to be delivered over the next few years for riverside habitat restoration.

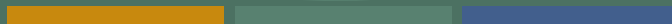

Investing in Homegrown Vision to Produce World-Class Results.

Investing in communities and living out the values that helped launch an iconic American business success story is the reason the Home Region Program was developed more than five years ago. The objective is clear: to invest in programs and initiatives that enhance the quality of life for people living in Northwest Arkansas and the Arkansas and Mississippi Delta Region.

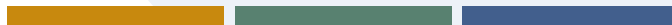


In 2014, the Home Region awarded over \$40 million in grants.

That same year, the Foundation unveiled the 2020 Home Region Plan, which includes an anticipated investment of more than \$302 million in the region.

With over 500,000 people now living in Northwest Arkansas, the Foundation is more focused than ever on working with our grantees to promote active transportation choices, create economic opportunities and preserve open space to help make Northwest Arkansas an even more desirable place to call home.

Likewise, in the Arkansas and Mississippi Delta, similar initiatives are supported to address educational improvement, public safety, youth engagement and targeted job creation. Opportunities abound in the Delta and the Foundation is committed to providing necessary resources to help make a difference in the lives of the people there.



Home Region Grantee Spotlights

TheatreSquared:

TheatreSquared launched a three-year strategic plan for growth, including expanded artistic programs, broader access to all segments of Northwest Arkansas, and a more prominent national role for TheatreSquared through high-profile productions and new play development. Their locally produced and nationally acclaimed productions reached over 30,000 patrons in 2014. TheatreSquared's Vision 2017 has big plans to increase this reach and bring national attention to the cultural amenities of Northwest Arkansas.



NWA Venture Team:

NWA Venture Team was established to provide access to mentorship programs, networking and capital for Northwest Arkansas entrepreneurial and STEM talent looking to enter the creative, startup scene. This team will focus on propelling the region to sustained new venture creation and high-wage/high-rate job growth, while increasing the reputation of NWA as a globally competitive destination for starting a business.



Home Region Grantee Spotlights

Innovative School Options:



Two school districts in Northwest Arkansas converted existing facilities to charter schools. Pea Ridge and Rogers are providing innovative public school options to the community and charting new ways for students to get their high school education. Pea Ridge Manufacturing and Business Academy's career-centered learning approach offers a variety of technical-skilled trades and professional opportunities to prepare students for life after high school. Rogers New Technology High School's instructional approach is centered on project-based learning with a strong emphasis on integrated technology in the classroom and providing a culture that empowers students and teachers.


Illinois River Watershed Sanctuary in Cave Springs:

The Watershed Sanctuary at Cave Springs was established to build awareness of the importance of the Illinois River Watershed, water quality concerns and ways in which the natural environment and water quality may be protected and improved. The 30-acre site is situated in the urban headwaters of the watershed with natural amenities embracing sustainable, green development. Some key features include an underground spring leading to a lake and limestone cave formation.
